#### **Terms and Conditions**

The following articles list our general terms and conditions of business and delivery for Subscription Membership to the ESHPh and Subscription to PhotoResearcher:

01. In the case of orders/registration without indication of a specific date, delivery will begin at the earliest date possible.
02. The subscription contract comes into effect with the confirmation of the subscription to PhotoResearcher or its delivery whereupon delivery, acceptance and payment become legally binding for both parties.
03. In general, subscription fees are due in advance. The prepaid subscription fee is guaranteed for the period covered by the prepayment and may not be increased. Any increases in price will be announced before coming into effect.
04. The reduced price of ESHPh membership price for students can only be granted on presentation of a valid certificate of enrolment.
05. No claims to supply or compensation will apply in the case of force majeure or labour dispute (strike, lockouts).
06. The punctual processing of changes in subscription, means of payment, banking information, deliveries, etc. can only be guaranteed if the ESHPh receives the appropriate notification at least 10 days in advance. The ESHPh is to be informed of any change in address.
07. The delivery of the PhotoResearcher journal and other published products is provided free-of-charge to ESHPh members. Delivery defects are to be reported without delay. In the case of non-delivery, late delivery or damage caused in delivery, the ESHPh will only accept responsibility for intent or gross negligence. No replacement will be made for publications of the ESHPh and other products that arrive in foreign countries late or not at all.
08. The ESHPh is justified in suspending delivery of the PhotoResearcher journal as soon as, and for as long as, the subscriber is in default of payment. The ESHPh is also justified in charging reminder fees and interest on arrears.
09. Supplements are integral parts of the PhotoResearcher journal and, for technical reasons, cannot be omitted.
10. Any change or addition to the previously mentioned conditions for ESHPh membership and/or subscriptions to the PhotoResearcher shall only come into effect when confirmed in written form.
11. Should any provision in these conditions be or become invalid, the General Terms and Conditions for ESHPh Subscribers will remain in force. The invalid clause shall be replaced by one that is valid and which most closely corresponds to the economic purpose which was intended with the invalid provision. The same applies in the case of any omission.
